	<b>HISTORICALLY UNDERUTILIZED BUSINESS ZONE (HUBZone)</b> - To qualify for this program, a small business must be (1) based in a "historically underutilized zone"; (2) owned and controlled at least 51% by U.S. citizens; and (3) at least 35% of its employees must reside in a HUBZone.
	<b>HISTORICALLY BLACK COLLEGES AND UNIVERSITIES (HBCU)</b> - Defined as any nationally accredited institution of higher education established prior to 1964 with a principal mission of educating African Americans. This definition also includes Indian-owned economic enterprises that meet the requirements of 25 U.S.C. 1452(e).
